

First-Time Setup Instructions 1/2

POWER REQUIREMENTS / TURNING ON AND OFF:

→ IMPORTANT: Only use a USB Type-C power adapter with 5V, 3A (not included). Too much current will harm the device, and too low voltage will cause it to run slowly (throttling). We strongly recommend using the official Raspberry Pi 4 power adapter. If you choose an alternative, it must be a USB Type-A to USB Type-C power cable.



- → The device will turn on automatically when power is connected. You will see the FRAME-1 splash screen.
- → To turn off the device, use the touch screen and press the "Shutdown Device" button. You can now safely unplug the device from your power outlet.

CONFIGURE TIMEZONE & WI-FI:

When setting up your FRAME-1 desktop companion for the first time, be sure to configure your timezone and Wi-Fi connection.

- → Use the touch screen and swipe up until you get to the page that says "Device Settings." Then press the "Configure Device" button. The device will reboot itself within 10 seconds into Configuration Mode and you should see a confirmation pop-up on the screen. IMPORTANT: This process may take up to 120 seconds, so please be patient.
- → After the device reboots, use your smartphone (or computer) and connect to the Wi-Fi network:"FRAME-1 Setup".
- → Scan the QR code displayed on the screen, or manually open your web browser and go to: 10.0.0.1 - then follow the on-screen instructions.

Operating Instructions

USING THE DEVICE:

- → NOTE: The capacitive touch screen require a firm touch to register.
- → Swipe up once to access "Display Options". From here you can:
 - Toggle metadata on/off. When you want some more information.
 - Toggle night mode on/off. Dims the content of the display with 50%.
 - Choose between a 12-hour clock or 24-hour clock. Set your time format.
- → Swipe up again to access "Playlist Customization". Here, you choose which playlist items you want your device to display. For example, if you only want to display the clock and date, toggle everything off except the Clock/Date option.
- → When a new software update is available, the device will automatically download and install it in the background, then restart itself. It checks for updates every 24 hours. Alternatively, you can manually update your device through the "Device Settings" menu.
